<b>Sl. No.</b>	<b>The school is directed to ensure that :</b>
1	The total number of permissible sections strictly shall be 28 only. In future for any increase in the number of sections, the school should obtain the specific approval of the Board as per rules and affiliation bye laws and availability of the classrooms not less than 500 sqr feet. In lower classes some sections have 45 students each, which is not permissible. The school shall restrict the number of students to 40 in each section.
2	The affiliation bye laws (rule 4.7.2, 4.7.3, 4.7.6 & 14.15) and the mandatory provisions of the RPwD , Act 2016 provides for adequate and CwSN friendly infrastructure and facilities in the school. The CwSN toilets should be at each floor for boys and Girls separately. The CwSN toilets in the school are small in size with narrow entrance to allow the movement and navigation of the wheelchair/walker. School should follow the provisions of RPwD, Act , NCPCR manual on student safety and the circular no 05/2023 ( <a href="https://saras.cbse.gov.in/SARAS/Circulars/Circular05_2023.pdf">https://saras.cbse.gov.in/SARAS/Circulars/Circular05_2023.pdf</a> ) for CwSN toilets and other facilities. School shall make provisions for separate CwSN toilets for boys and girls on each floor with proper permanent signage with infrastructure as per circular no .05/2023 and shall upload the compliance on SARAS portal within 03 months with compliance video link.

3	School should upgrade the Composite Science Lab. The the number of instruments are not adequate and sufficient as per the section strength. The lab is also undersized and should be shifted in room of adequate size as per rule 4.2 of affiliation bye laws and there should be availability of water sink, fire extinguisher, exhaust, seating tables etc. School should upgrade the Science lab as per SoP vide circular no.11/2022 and upload the compliance on SARAS portal within 03 months.
4	The ramp at the entrance is steep and serrated. The ramp at the entrance should be CwSN friendly with adequate slope and safe movement of wheelchair/walker. School should modify the same as per Circular No. 05/2023 and upload the compliance on SARAS within 03 months.
5	The library need to be shifted in a big hall of adequate size. The library has no separate reading facility for teachers and the seating arrangement for students is also not sufficient due to running number of section and students strength. School comply with the SoP dated 04.10.2022 for infrastructure in library (circular no. 11/2022) and upload the compliance on SARAS portal within 03 months.
6	The waste building material is seen lying at some places in school campus which should be removed and campus be kept clean. School should rectify this within three months and upload the compliance on SARAS.
7	The school shall ensure the training of its teachers with CoE, Pune three months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.
